#### *Collaboration on Usher in a life perspective*

This is not a formal network, but the group is very active and will be encouraged to apply to become a network in the future. Their webinars have gathered quite an audience.

During the last years, the different networks have been quite visible as they have published books, booklets and held a number of seminars. It was suggested that a yearly webinar, where the networks could present their work, may be a good idea to spread knowledge to the Nordic countries. In return the Nordic countries themselves should establish routines to facilitate dissemination of knowledge nationally.

#### *Status on working groups/projects*

##### *Nordic master*

NWC coordinates the working group. The group is still active and the idea of the Nordic master has not been abandoned. One of the challenges has been to find a university to host a Nordic master. There is also a question about getting an acceptable number of applicants for a master program. Maybe a collaboration with the University of Groningen is the solution? And in addition, investigate whether other universities could host courses/modules at a master level? NWC will communicate the forum's thoughts to the working group.

##### *Tactile transition*

A presentation will be given on the Nordic conference in September, and the group will arrange a webinar in November.

##### *Nordic Conference*

NWC will arrange a dinner in Tampere for the leadership forum on Tuesday evening.

At the social dinner on Wednesday, we will celebrate the 50<sup>th</sup> anniversary of Kuurosokeat. An idea to greet colleagues about to retire, was also submitted. Organizations with colleagues at the end of their career, please send information to Saga within a week before the dinner.

All the networks will present themselves at the conference. There will also be possible to form new networks during the conference.

Nordic definition and Nordic study plan (congenital and acquired)

#### *Nordic definition*

The Nordic definition will be reviewed every four years, to ensure a common understanding. Names for a group to conduct the work, should be sent to Maria within July the 5<sup>th</sup>.

#### *Curriculum*

The curriculum will be revised, but the work will not start until the beginning of 2023.

#### *New Project Leader for Deafblind Issues*

The recruitment process for a new Project Leader for Deafblind Issues is ongoing, and will be completed during the summer. Maria resigns at the end of August, but will moderate the Nordic conference in September. Gunnar Mikkelsen will replace Maria as responsible for planning the conference. As soon as a new advisor is recruited, the leadership forum will be notified.

#### 11. Group and plenary discussion

Mandate, Nordic Council of Ministers, Maria Creutz.

A proposal for a mandate was shared before the meeting. The mandate will be active from 2023 until 2025. Plenary discussions on the mandate.

“Nordens Välfärdscenters roll”

“Syfte och oppdrag”

The Nordic leadership forum *suggests* activities, projects and themes for expert groups.

The mandate should be more precise in terms of what NWC is supposed to finance. NWC cannot overrule decisions from the leadership forum, but NWC may reject to finance.

### “Organising”

It was suggested that at least one representative from each organization listed in the addendum, should be member of the leadership forum. The role as host of the meetings in the forum rotates among the Nordic counties in a predefined order. NWC will lead the meetings.

The addendum was updated in the meeting.

A revised mandate will be shared, with a deadline for possible further comments.
